ORDER

The instant petition is filed by Aether Alloys LLP, Naharlagun, Arunachal Pradesh under Regulation 12, 13 and 43 of Arunachal Pradesh State Electricity Regulatory Commission (Conduct of Business) Regulation, 2011 read with Regulation 8.7 of the Arunachal Pradesh State Electricity Regulatory Commission (Electricity Supply Code) Regulation, 2024, (hereinafter referred to as the "2024 Supply Code")

Juni ras (V. Sousivas) Secontary seeking relaxation of Regulation 3.21.4(1) read with Annexure 10.10 of 2024 Supply Code relating to security deposit for the new connection.

- The instant petition is filed by the Petitioner seeking reduction in the security 2. deposit to be made by the Petitioner by relaxing the Regulation 3.21.4(1) read with Annexure 10.10 of the 2024 Supply Code. However, it has been titled as a review petition. When we pointed out this issue during the hearing on 25.7.2024, the learned counsel for the Petitioner submitted that they were not aware of the provisions under which the petition has to be filed and sought permission to withdraw the petition with a liberty to file a fresh petition. The learned counsel further requested to adjust the fee paid in this matter towards the fee that is required to be deposited in the fresh petition to be filed by the Petitioner.
- Taking into consideration the learned counsel's request, we allow the Petitioner 3. to withdraw the instant petition and file a fresh petition as per the provisions of law and the regulations along with all the details. The Petitioner is also directed to submit legible copies of the documents, as some of the documents filed by the Petitioner in the instant petition are not legible. Further, the fee paid by the Petitioner in the instant case shall be adjusted towards the fee towards the fresh petition that will be filed by the Petitioner.
- 4. Accordingly, Petition No. MP-06 of 2024 is disposed of.
