
ORDER

1. The Commission being empowered under the provisions of Section 86 of the Electricity Act, 2003 to monitor and ensure efficiency, transparency, and economic viability in matters related to electricity trading in the State. Further for any inquiry or proceeding, the Commission is vested with powers under Section 94 of the same Act to summon and enforce the attendance of any person to give information and evidence as may be necessary for the performance of its functions.

2. The Commission in exercise of its powers, issued a notice dated 2.05.2025 to the noticee M/s Arunachal Pradesh Power Corporation Pvt. Ltd directing to present briefing on the transactions related to the sale of surplus power during the last five [ 5 ] financial years. For better understanding into the matter, it was further directed that briefing/presentation should be delivered via power point along with hard copies of the same. The presentation was fixed on 13.05.2025.
3. On the request for extension of time by the noticee vide letter No. APPCPL/APSERC/NHLN/2025-26/001, dated 09.05.2025, this Commission had fixed the briefing/presentation on 10.06.2025, but to unavoidable circumstances, the same was rescheduled on 12.06.2025.
4. The Commission note that on the date of briefing/presentation, Mr. Anand Shankar Roy, Assistant General Manager, M/s Arunachal Pradesh Power Corporation Pvt. Ltd had come with an intent to submit documents and was adamant to make any briefing/presentation as directed. With the situation as same, the official failed to delivers the briefing/presentation.
5. Seeing the act as deliberate and willful non-compliance, a notice dated 12.06.2025 was issued under Section 142 and 146 of the Electricity Act, 2003. Further affording a last chance to the noticee, the matter was fixed on 18.06.2025.
6. Today, when the matter was called for, Mr. Ajay Kumar, Senior Adviser, M/s Arunachal Pradesh Power Corporation Pvt. Ltd appeared and humbly placed its submissions.
7. In its submissions, he has regretted for the misunderstanding and sought apology for not making a detail presentation for the information sought and compliance, the noticee is ready to make the presentation in PowerPoint.


