NOTIFICATION

The 17<sup>th</sup> August, 2011

No. APSERC/NOTIFICATION/1/2011 - In exercise of powers conferred under Section- 181 read with Section 87 and 88 of the Electricity Act, 2003(Act No. 36 of 2003), the Arunachal Pradesh State Electricity Regulatory Commission (APSERC) do hereby establish the State Advisory Committee consisting of the members mentioned in subsequent paras.

## 1. Short title and commencement:

- (i) This notification may be called Arunachal Pradesh State Electricity Regulatory Commission's "State Advisory Committee (SAC) Notification, 2011".
- (ii) This Notification shall come into force with effect from 17<sup>th</sup> day of August, 2011.

## 2. Definitions: In this notification, unless the context otherwise requires:-

- (i) "Act" means the Electricity Act, 2003 and
- (ii) "SAC" means State Advisory Committee
- (iii) Commission means Arunachal Pradesh State Electricity Regulatory Commission.
- (iv) Words and expression used herein and not defined but defined in the Act, shall have the meanings respectively assigned to them in the Act.

#### 4. Main Terms of Functioning:

- (i) The SAC shall meet at least once in six months or months or such intervals and at places as may be decided by the Commission.
- (ii) The quorum at the meeting shall be 1/3<sup>rd</sup> of the Total membership of the SAC.
- (iii) **Provided that attendance by proxy shall not be permitted at the meeting of the SAC.**
- (iv) Provided further that the Chairperson may invite any person who is not a member of the SAC as a special invitee to aide and assist the members of the SAC on any matter on the agenda of its meeting.
- (v) The members are appointed for a term of one year, which may be further extended at the discretion of the Commission
- (vi) The notice and the agenda for the meeting of the SAC shall be sent to the members at least seven days before the date of meeting.

#### 5. Powers to Remove Difficulties:

If any difficulty arises in giving effect to any of the provisions of these Rules, the Commission may be general or special order, may take such action, as may appear to the Commission to be necessary or expedient for the purpose of removing difficulties.

#### 6. Powers to Amend:

The Commission may, at any time add, vary, alter, modify the composition of the SAC within the ambit of the Act.
