# MOST RESPECTFULLY SHEWETH:

- The petitioner had submitted a petition praying for approval of new service connexion charges in electrified areas up to a load of 150 kW in compliance of clause No. 3.6.4(10) of Arunachal Pradesh State Electricity Regulatory Commission (Electricity supply code) regulation 2024 Petition vide No. CE(COM)/EoL/152/2024-25/789-86 dated 20-06-2024.
- The Hon'ble Commission had admitted the petition and designated as Petition No. MP-04 of 2024 vide his correspondence No. APSERC/RA-9/III/2024-25/185 dated 21-06-2024
- 3. On 26-07-2024, the Hon'ble Commission had passed an Order on Petition No. MP-04 of 2024.
- 4. That the Petitioner begs to submit that several video conferences were conducted by the Joint Secretary (Power), Government of India during which he had expressed



repeatedly that the **New Service Connection Charges** should be **per kW** up to 150 kW of Load in **Electrified Area** as per the decision taken in the 3rd National Conference of Chief Secretaries, chaired by the Hon'ble Prime Minister of India. As such, the leaned Joint Secretary (Power), Government of India, observed that the order issued by the Hon'ble Arunachal Pradesh State Electricity Regulatory Commission does not comply with the resolution of the 3rd National Conference of Chief Secretaries since the New Service Connection Charges Order dated 26-07-2024 is based on distance.

5. That the Petitioner respectfully submits that during the last video conference held on 29-11-2024, the Joint Secretary (Power), Government of India, directed the Department of Power, Government of Arunachal Pradesh, to file a Review Petition before the Hon'ble Arunachal Pradesh State Electricity Regulatory Commission to review the Hon'ble Commissions Order dated 26-07-2024 so as to specify the New Service Connection Charges on a per kW basis for New Service Connection up to 150 kW in the Electrified Area.

## **PRAYER**

In view of the above facts and circumstances, the Petitioner most respectfully prays that the Hon'ble Arunachal Pradesh State Electricity Regulatory Commission may graciously be pleased to:

- 1. Admit this Review Petition and consider issuing an order revising the New Service Connection Charges on a per kW basis for loads up to 150 kW in electrified areas, in line with the resolution of the 3rd National Conference of Chief Secretaries.
- 2. Pass any other relief or direction that the Hon'ble Commission may deem fit and proper in the interest of justice and compliance with national policy directives.

And for this act of kindness, the petitioner is duty bound shall ever pray.
