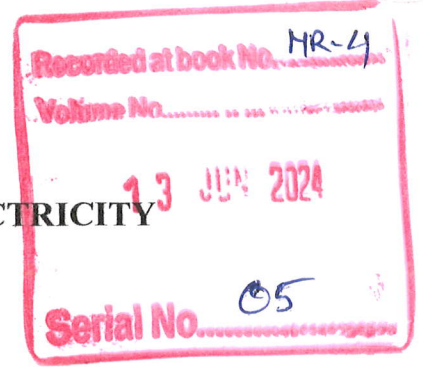

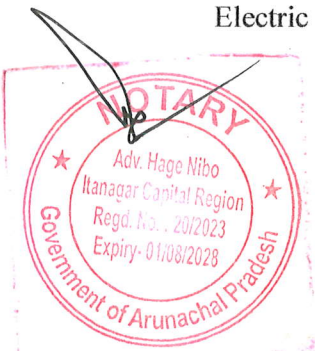

IN THE MATTER OF:

The Chief Engineer (Commercial) cum CEI, Department of Power, Itanagar – 791111. (Arunachal Pradesh) and M/s Buru Energy Private Limited for Dengzi Hydro Electric Project 10MW, a company incorporated under the Companies Act, 2013 having its registered office at – C/o Bamang Tago, Yara Tabang Complex, ESS Sector, Near Govt. High School, District Papumpare, Itanagar-791111, Arunachal Pradesh.

The Petitioner most respectfully submits as follows:

1. M/s Buru Energy Private Limited for Dengzi Hydro Electric Project 10MW, having its registered office at – C/o Bamang Tago, Yara Tabang Complex, ESS Sector, Near Govt. High School, District Papumpare, Itanagar-791111, Arunachal Pradesh.
2. A Memorandum of Agreement (MOA) was signed between M/s Buru Energy Private Limited for Dengzi Hydro Electric Project 10MW, a company incorporated under the Companies Act, 2013 having its registered office at – C/o Bamang Tago, Yara Tabang Complex, ESS Sector, Near Govt. High School, District Papumpare, Itanagar-791111, Arunachal Pradesh, and Govt. of Arunachal Pradesh represented by Secretary (Hydro Power) on 24-11-2015.
3. As per Clause 4 of amended MoA, M/s Buru Energy Private Limited for Dengzi Hydro Electric Project 10MW, agree to give 2.5% Free Power after a moratorium period of 2 year.



4. As per MoA Clause 5.2, The Arunachal Pradesh State Govt. has the first right to purchase the power generated from the project at a tariff 10 paisa lower than the tariff as determined by the CERC/SERC or the State Govt, as the case may be. The approval of the Competent Authority is obtained for Power Purchase from Dengzi Hydro Electric Project 10MW, vide file No.CE(COM)/PPA/DENGZI/113/2023-24 (Computer No. 142972) Note # 31 dated 05/12/2023.
5. The Petitioner has got the Draft PPA duly vetted by the Law Department vide file No. CE(COM)/PPA/DENGZI/113/2023-24 (Computer No. 142972) Note #53 dated 28/02/2024 and Finance Department vide file No. CE(COM)/PPA/DENGZI/113/2023-24 (Computer No. 142972) Note #77 dated 05/12/2-24.
6. Draft Power Purchase Agreement (PPA) duly agreed and initiated by both the parties is attached herein with the petition; and
7. The Petitioner, now seeks the Approval of the APERC on the Draft Power Purchase Agreement (PPA).



2. The statements made in the petition is based on the information received from the official records of the department maintained in the ordinary course of business and is believed to be true to the best of my knowledge.


