**Recording of Proceeding**

1. The matter has been called up for admission hearing.
- 2.The Department of Power, Arunachal Pradesh, being the petitioner has filed the instant petition for approval of Power Sale Agreement (PSA) between Department of Power, Government of Arunachal Pradesh and M/s Shree Salasar Industries Private Limited.
3. Petitioner's representative submits that there is a load sanction for an electrical load of 18 MW in favour of M/s Shree Salasar Industries Private Limited Vide Load Sanction Order No. CE(P) /WEZ/SLDC/P-SALE-IX/2009-10/1655-63, dated 22.07.2010 .
4. That the above sanction order was subject to the terms and conditions of the Power Sale Agreement (PSA) which was to be executed between the petitioner and M/s Shree Salasar Industries Private Limited but

before the agreement would be executed , the petitioner started supplying power to the other party from 15.11.2010.

**5.** That after a period of 12 years since the 18 MW power was supplied to the other party i.e M/s Shree Salasar Industries Private Limited a representation was submitted to the petitioner to entered into Power Sale Agreement (PSA) .


**6.** The petitioner representative submits that matter was placed before competent authority for administrative approval . In this regard a draft Power Sale Agreement(PSA) was also vetted by the Department of Law and Department of Finance, Government of Arunachal Pradesh.

**7.** The petitioner further submits that M/s Shree Salasar Industries Private Limited in the year 2015 has deposited inadequate Security Deposit ( S.D) of Rs 90 lakhs as reflected in PSA and till this date there is no any bill due against the petitioner. The petitioner fairly admits the fault and negligence on their part about non-compliance of the statutory provisions.

**8.** Also seen the notice dated 26.09.2024 issued by the Commission whereby a copy to also served upon the M/s Shree Salasar Industries Private Limited.

**9.** The counsel Mr. Rubu Tani appeared on behalf of M/s Shree Salasar Industries Private Limited and prayed that two weeks time may be granted for filing of Vakalatnama and other necessary documents .


**10.** Prayer allowed.
