## **Recording of Proceeding**

- 1. As seen from the Recording of Proceeding, dated 29.10.2024, the Commission had after submissions of both parties, reserved it for Order, but it was felt necessary to get a clarity on the contents of the letter, dated 02.02.2024 which was paced on records by the respondent, being the communication by the petitioner to the Executive Engineer, Tawang Electrical Division, Department of Power, Arunachal Pradesh.
- 2. To get a clear picture on the contents of the letter dated 02.02.2024, notice was issued to both the parties to attend the Technical Validation Session (T.V.S) fixed on 13.11.2024. The Respondents, Department of Power, Arunachal Pradesh were represented by Er. D Tacho, Chief Engineer (Comm), Er T K Tara, Chief Engineer (TPMZ), Er. Sange Phunso, Executive Engineer, Tawang and Er. Nido Taka, Executive Engineer (TPMZ). From petitioner side, Shri Ch. P Mishra, Director and Shri Neeraj Kumar, General Manager appeared. After hearing both the parties, it was felt that further hearing was necessitated to bring the matter to its logical conclusions. The parties were at liberty to place relevant documents to sustain their arguments.
- 3. The matter was re-fixed to be heard on 30.12.2024.
- 4. That petitioner, on dated 26.11.2024 had filed their additional affidavit. On the prayer made by the respondent seeking additional time to file their reply, the Commission, on recording of Proceeding, Dated 30.12.2024 had allowed additional 20 [Twenty] days to filed reply. The matter was fixed on dated 10.02.2025 for final hearing
- 5. The respondent, Chief Engineer (Power), Western Electrical Zone on dated 21.01.2025 had filed their reply to the additional affidavit filed so by the petitioner.
- 6. The petitioner as to the reply of the respondent's contentions, filed a rejoinder, dated 27.01.2025.
- 7. That the matter has been listed up for final hearing on 10.2.2025.
