## **Record of Proceedings**

- 1. The Petitioner has filed the present petition seeking a review of the Order dated 04.03.2025 passed by this Commission in Petition No. TP-07 of 2024.
- 2. The Petitioner is represented by Mr. Dorjee Wangdi Thungon, Administrative Officer. During the course of submissions, he sought an adjournment of the proceedings on the ground of a prior commitment of the Managing Director, who, being fully conversant with the facts of the case, was unable to attend the hearing.
- 3. The Respondent, represented by Er. Duyu Tacho, Chief Engineer(P)(Comm),
  Department of Power, Government of Arunachal Pradesh, raised no objection

- to the request for adjournment. However, he submitted that the order dated 04.03.2025 has not yet been implemented by the Petitioner.
- 4. The Respondent, further submitted that the bill for the month of April-2025 continues to be raised at the tariff rates applicable for the Financial Year2024-25. The Respondent prayed that any delay in payment arising due to this discrepancy should not attract any surcharge and that the Petitioner be directed to issue invoices in accordance with the revised tariff rates as determined by the Hon'ble Commission in its Order dated 04.03.2025, in the absence of any stay or interim relief granted to the Petitioner.
- 5. The Commission reiterates that both parties are under a statutory obligation to implement the Tariff Order dated 04.03.2025 and accordingly directs both parties to comply with the said order in letter and spirit.
- 6. In so far as the request for adjournment is concerned, the Commission finds merit in the ground cited and accordingly allows the prayer for adjournment.
- 7. The Review Petition shall be listed for hearing on the point of admission on **11th June 2025 at 11:00 AM** in the Courtroom of the Commission.
