- 2. The petitioner had submitted 3 [three] copies of the petition along with the requisite fee.
- 3. The commission by its letter, dated 29.01.2025 had directed the petitioner to publish the petition details in abridged form in local newspapers, seeking comments and suggestions from public and stakeholders giving 21 days' time period.
- 4. In compliance of the direction, the petitioner on 05.02.2025 had published the tariff petition in abridged form in local Newspapers namely 'Echo of Arunachal' and 'Eastern Sentinel'. Due to clerical errors, the petitioner again on 06.02.2025 republished the public notice in one local newspaper 'Eastern Sentinel'.
- 5. In order to provide opportunity to Stake holders and Public in general to raise concern on the above petition, public hearing was fixed on 25.03.2025 at 11.00 AM at Commission Court room.
- 6. Today, the matter has been listed up for Public Hearing.
- 7. Er. Rajesh Sharma J.E, Commercial, representative of DOP, AP and Mr. Nagaraju, M D, DEPL appeared.
- 8. Seen that, no comments or any suggestions have been received by any stake holder nor any general public.
- 9. The petitioner's representative in its submission had prayed that he may be allowed to filed a rejoinder, as part of incentives has not been included in the tariff petition. Further the petitioner prayed for 2 [two] weeks' time to submit the compliance report on the status of the directives issued by the Commission in its Order.
- 10. On the query from the Commission regarding True Up for FY 2023 -24 and APR of FY 2024-25, the petitioner prayed to allow to submit this additional information at the time of filing rejoinder within 2₁[two] weeks.

- 11. The Representative of the DOP, AP on the other hand also had to submit the compliance report on the status of the directives issued by the Commission. It is noticed that representative of the DOP, AP on many occasions has not been able to give proper explanation to the queries raised by the Commission. The Commission reprimanded that DOP, AP must authorize such persons having duly acquainted with facts of the case.
- 12. Prayer allowed. The parties are granted 2 [two] weeks' time to submit the compliance report on the status of the directives issued by the Commission in its Order. Mean time the petitioner may file their rejoinder as prayed for.
- 13. List the matter again for further hearing on 22.04.2025 at 11.00 AM in Commission's Court room.
