
Record of Proceedings

1. This present petition is being filed by petitioner, State Load Despatch Centre, (SLDC), Arunachal Pradesh for approval of Multi Year Aggregate Revenue Requirement for FY 2025-26 to FY 2029-30 & SLDC Charges for FY 2025-26.
2. As mandatory under the regulations, the Commission vide letter dated 03.03.2025 had directed the petitioner to publish the petition in abridged form in two local newspapers, inviting objections / Suggestions giving 21 days time period from consumers and stake holder.
3. The petitioner as directed, published the abridged form of the petition on 03.04.2025 and 04.04.2025 in local newspapers namely, The Arunachal Times, Echo of Arunachal Times, The Arunachal Age, Eastern Sentinel and The Arunachal Pioneer.

4. In order to provide opportunity to Stake holders and Public in general to raise any queries or concern on the above petition, a notice, dated 29.04.2025 was issued by the Commission regarding public hearing. The date of public hearing was fixed at 14.05.2025.
5. When the matter was called up for Public Hearing. It is seen that no comments or any suggestions have been received by the Commission from any stake holder or by general public.
6. On behalf of the petitioner, arguing representative Sri Sayak Mondol, Consultant, SLDC while making submission made brief presentation in Power Point (PPT).
7. On queries raised to the non-availability of vital documents in the present petition in regard to Repair & Maintenance (R&M), Administration & General (A&G) and Employee Expense (E E). The petitioner assures the Commission to submit it within a week time.
8. Also seen that the petitioner has failed to submit necessary documents pertaining to the audited accounts report of State Load Despatch Centre audited by Accountant General (A G) or any statutory auditor. On insistence, the petitioner submitted that all necessary steps shall be initiated to get the audited account report at earliest possible.
9. On the prayer made by the petitioner, further a week time is allowed to the petitioner to submit all available documents covering para 7 and para 8 of the above.
10. The Commission, if necessary, may fixed the matter for further hearing, for which Prior intimation will be notified to the parties.
