
**Recording of Proceeding**

1. The matter has been listed up for further hearing.
2. The respondent, Department of Power , Government of Arunachal Pradesh, represented by Er. Tapi Tai submitted that since the matter is of complex nature, more time is needed to review the additional affidavit submitted by the petitioner. As such, the respondent had prayed for additional 30 days to file their reply.
3. After hearing both parties, the Commission in the interest of justice grant another 20 [twenty] days period to the respondents to file their reply, if any .
4. The respondent shall file their reply on or before **21.01.2025**. A copy of the reply must be served upon the petitioner in advance.
5. The petitioner may submit their rejoinder affidavit, if any within 7 [seven] days from the receipt of the reply copy filed by the respondent, but not later than **28.01.2025**.
6. It is directed that reply filed by the respondent has to be specifically on the additional affidavit submitted by the petitioner. New contentions or arguments shall not be considered by the Commission.
7. The matter shall be listed for further hearing on **10.02.2025. at 11.00 AM**.
