AFFIDAVIT IN REPLY OF ARUNACHAL PRADESH STATE ELECTRICITY REGULATORY COMMISSION (APSERC), ITANAGAR, RESPONDENT NO. 24.

I, Marjum Karlo, Son of Late Tamar Karlo, aged about 49 Years, presently residing at C Sector, Near G G Drug House, Naharlagun, Papum Pare District, Arunachal Pradesh, 791110.

- I say that, I am presently serving as Secretary (In-Charge), Arunachal Pradesh State Electricity Regulatory Commission (APSERC), having its office at O.T Building, 2<sup>nd</sup> floor, Niti Vihar, Itanagar, Papum Pare District, Arunachal Pradesh.
- 2. That I have been arrayed as the Respondent No. 24 in the aforesaid Suo Moto petition. I have read and understood the contents of the Hon'ble Appellate Tribunal for Electricity's Order dated 29.08.2025

in OP No. 1 of 2025. I am aware of the facts of the order and am competent and authorised to file present affidavit on behalf of Arunachal Pradesh State Electricity Regulatory Commission.

3. That Hon'ble Appellate Tribunal for Electricity by its Order dated 29.08.2025 had directed all Regulatory Commission, calling upon them to file an affidavit within two weeks furnishing details of

" (a)the Regulatory Assets with respect to each Discoms, within their jurisdiction, as on 01.04.2024;

- (b) the Revenue Gap (whether carried forward or not) as reflected in each ARR upto 01.04.2024;
- (c) the trajectory/ roadmap for liquidation of these Regulatory Assets/ ending the revenue gap upto 01.04.2024, so as to ensure that the entire Regulatory Assets/ Revenue Gap is liquidated latest by 31.03.2028;
- (d) the steps taken by each of the Commissions to commence an intensive audit of the circumstances in which the Distribution Companies, operating within their jurisdiction, have continued to function without recovery of the Regulatory Assets/ Revenue Gap; and
- (e) the year upto which each of these Commissions have passed true up/ ARR orders with respect to each of the Distribution Companies within their jurisdiction."
- 4. In compliance to the said direction of the Honorable APTEL the reply on point wise details sought from Arunachal State Electricity Regulatory Commission (Respondent no 24) is given here below:

(a) The Regulatory Assets with respect to each Discoms, within their jurisdiction, as on 01.04.2024;

Reply from APSERC: The distribution of electricity within the State of Arunachal Pradesh is presently undertaken solely by the Arunachal Pradesh Department of Power (APDoP), Government of Arunachal Pradesh, which is a deemed licensee under Section 14 of the Electricity Act, 2003. As on 01.04.2024, no regulatory asset exists in relation to APDoP.

(b) The Revenue Gap (whether carried forward or not) as reflected in each ARR upto 01.04.2024;

**Reply from APSERC:** No revenue gap has been carried forward, as no such gap exists to date. The gap, as computed by the APSERC, is being fully funded by the Government of Arunachal Pradesh, and consequently, no revenue gap exists as on date.

(c) The trajectory/ roadmap for liquidation of these Regulatory Assets/ ending the revenue gap upto 01.04.2024, so as to ensure that the entire Regulatory Assets/ Revenue Gap is liquidated latest by 31.03.2028;

**Reply from APSERC:** In view of the fact that no regulatory asset exists as on date, no roadmap for the liquidation of any regulatory asset has been formulated.

(d) The steps taken by each of the Commissions to commence an intensive audit of the circumstances in

which the Distribution Companies, operating within their jurisdiction, have continued to function without recovery of the Regulatory Assets/Revenue Gap; and

**Reply from APSERC:** Not applicable for the state of Arunachal Pradesh as no regulatory asset exists.

(e) The year upto which each of these Commissions have passed true up/ ARR orders with respect to each of the Distribution Companies within their jurisdiction.

**Reply from APSERC:** The Arunachal Pradesh State Electricity Regulatory Commission has, as on date, issued the True-up Order for FY 2023–24 and the ARR Orders up to FY 2025–26, in addition to approving the projected ARR for the forthcoming control period, i.e., FY 2025–26 to FY 2029–30.

5. That as per the direction, the respondent No.24 has submitted the facts in the above paragraphs which may be taken into consideration by the Hon'ble Tribunal.
