#### **GENERAL TERMS & CONDITIONS:**

- 1. Normal working hours would be as per the Order issued by the Government of Arunachalf Pradesh from time to time. The personnel may be called on a Saturday, Sunday and other gazetted holidays, and also asked to sit beyond normal working hours in case of necessity.
- 2. In addition to holidays notified by the State Government, the Consultants shall be entitled for leave as notified by the Commission from time to time.
- 3. Consultants appointed shall be governed by the provisions of the APSERC Appointment of Consultants Regulations-2018 and as amended from time to time and in future too. Copy of the Regulation is available on APSERC's website viz. www.apserc.nic.in
- 4. **DURATION OF CONTRACT**: The contract will be initially for a period of 3 years which can be extended for upto five years. In deserving cases an annual escalation as deemed fit by the Commission may be given based on the performance during preceding year.
- **5. PAYMENT TERMS**: The consultant shall be paid lump sum monthly remuneration (the agreed amount) on completion of the month. TDS shall be deducted as per Income Tax rules.
- **6. TERMINATION OF CONTRACTS:** The assignment may be terminated earlier by either the employer or the employee by giving one month's notice, or one month's salary in lieu thereof. Provided, in case of disciplinary action the notice period shall not apply to APSERC.
- 7. Appointment under this assignment shall be on purely contract basis for a limited period only. Such appointment shall not vest any right to claim for regular appointment in APSERC.
- **8.** APSERC reserves the right not to fill up all or any of the above-mentioned positions, without assigning any reasons what so ever.
- **9.** Only short listed candidates will be called for an interview to be taken by the Selection Committee.
- 10.
