1. The sale by auction will be on **"AS IS WHERE IS BASIS"**. The tenders shall have to quote the minimum offer amount in both figures as well as in words for the above vehicle along with name and permanent address of the tender in sealed cover and submit the same to the undersigned on or before 15/02/2024 at 1530 hrs. The sealed cover should be superscripted **"TENDER FOR PURCHASE OF OLD VEHICLE "**.
2. The intending tenderer may inspect the vehicle in the premises of **Type-V Quarter, Niti Vihar, opposite Buddhist Monastery, Itanagar between 10000 hrs to 1600 hrs** with due permission from the Secretary, APSERC, Itanagar from the date of receipt/publish in newspaper.
3. Further, an earnest money @5% on the vehicle's reserved price in the form of Banker Cheque/Bank Draft in favour of the Secretary, APSERC, Itanagar payable at Punjab National Bank, Itanagar Branch should be deposited along with the quotation/tender paper by the intending tenderer. Earnest money in any other form shall not be accepted.
4. The earnest money of the successful bidder shall be refunded on payment of tendered amount in full, while that of the unsuccessful bidder shall be refunded on completion of auction process.

The successful tenderer shall have to deposit the full value of his/her offer within 3(three) days from the date of acceptance of his/her offer by the undersigned and vehicles be lifted within 3(three) days from the date of depositing the bid money, failing which the earnest money will be forfeited and vehicles will be disposed of in any manner as decided by the authority.
